Immigration Detention System

- Powerful tool
- Isolation
- Conditions of confinement
- Hostile jurisdictions
- Few Attorneys: 30% of detention facilities are 100 miles from nonprofit providers





Crisis of representation in detention

- 14% of detained immigrants have counsel
- Fewer than 2% of detained immigrants obtain pro bono representation
- Immigrants with counsel are 10 times more likely to prevail than unrepresented immigrants



Asylum in the U.S. Since 1980

Eligibility based on:

- Persecuted/likelihood of persecution because of
- Race, religion, nationality, political opinion, or membership in a particular social group
- By government/those government unable or unwilling to control
- Stability:
 - Provides a pathway to a green card, citizenship
 - Spouse and minor children can get asylum

Asylum Ban: What It Says

- Anyone who enters/attempts to enter U.S. via southern land border after July 15, 2019 is ineligible for asylum
 - Unless s/he applied for and was denied asylum in a third country en route to U.S.
 - Or was a victim of a severe form of trafficking

Supreme Court Decision

- Litigation in Northern District of CA
 - Challenge filed immediately
 - District Court judge issued nationwide injunction
 - 9th Circuit limited injunction to 9th Circuit (CA, AZ)
- Supreme Court decision on Sept. 11
 - Struck down entire injunction
 - Rule now goes into effect nationwide
- Not the end of the story litigation continues in California

What This Means for Asylum Seekers

- Will be eligible to apply for related protection: withholding of removal and Convention Against Torture protection
 - Harder to obtain
 - Less robust forms of protection
- Legal representation more crucial than ever

Who is Affected?

Non-Mexicans crossing southern land border

- Asylum seekers from all over the world will be affected
 - Ineligible for asylum
 - May be afraid to seek protection in U.S.
 - May attempt to enter by sea

Remain in Mexico: Overview

- Officially "Migrant Protection Protocols."
- Forces people to wait in Mexico for their U.S. immigration court hearings.
- Began January 24, 2019.
- Applies in much of the southern border, including Tijuana, Mexicali, and Juarez/El Paso.
- Over 40,000 adults and children have been made to wait in Mexico.

Remain in Mexico: Who it Impacts

- Does not apply to Mexican nationals.
- Does apply at and between ports of entry.
- Non-Mexicans who are found to be more likely than not to face persecution or torture in Mexico are not supposed to be returned to Mexico.
- Media documented only 2 people subjected to this policy who won asylum so far.

Why is it bad to force asylum seekers to Remain in Mexico?

- DANGEROUS: Border areas are very dangerous and asylum seekers are incredibly vulnerable to kidnapping, rape, and other violence.
- NO RESOURCES: Most have no support network or jobs in Mexican border towns and shelters are at capacity.
- NO ATTORNEYS: At the end of August, just 6% of these hearings had legal representation.

Port Courts

- Administration setting up massive tent "courts" near border for MPP cases
 - Laredo hearings started Sept. 11
 - Brownsville hearings started Sept. 12
- Judges appear by videoconference

Access to counsel severely restricted

Attacks on Legal Bases for Asylum

- Attorney General decisions in 2018 and 2019 that attack certain eligibility categories – attempt to foreclose these claims
- Survivors of domestic violence and gang violence
 - Matter of A-B- (June 2018)
- People targeted because of family relationships
 - Matter of L-E-A- (July 2019)

What This Means for Asylum Seekers

Harder to win asylum in these categories

- Decisions do NOT in fact foreclose asylum/withholding for these categories
- Need for legal representation
